CONTRACT CARRIER AGREEMENT

This agreement, between Boyd Transportation Group, Inc., Property Broker and _____

(hereinafter referred to as CARRIER),

will become effective on this _____ day of 20_____.

- 1 BOYD TRANSPORTATION GROUP, INC. is duly licensed by the Federal Highway Administration to engage in interstate operations as a broker...
2 Upon acceptance of lawful shipments of property offered by BOYD TRANSPORTATION GROUP, INC., CARRIER agrees to transport property...
3 CARRIER agrees to maintain and keep in full force a minimum of \$100,000 per vehicle General Liability Insurance and Cargo Liability Insurance...
4 CARRIER, at its own expense will provide safe and legal equipment to transport the property assigned by BOYD TRANSPORTATION GROUP, INC. in accordance with this agreement...
5 CARRIER agrees to immediately notify BOYD TRANSPORTATION GROUP, INC. of any and all accidents or cargo damages incurred in the transportation of the property assigned by BOYD TRANSPORTATION GROUP, INC...
6 CARRIER agrees to furnish BOYD TRANSPORTATION GROUP, INC. original signed bills of lading, scale tickets and lumber receipts, when required, and a CARRIER company invoice in order to receive compensation for their freight transportation services...
7 CARRIER understands that the rate confirmation sheet signed by both parties will be the agreed amount paid by BOYD TRANSPORTATION GROUP, INC. No additional amounts will be paid unless negotiated by both parties and a revised rate confirmation sheet signed by both parties...
8 Upon signature of this contract, CARRIER agrees that it will neither directly nor indirectly contact nor communicate with the customers of BOYD TRANSPORTATION GROUP, INC. for the purpose of soliciting freight for a term of up to and including two (2) years from the termination of this agreement by one or both parties...
9 CARRIER shall not have the right to place a lien on any shipment or portion of a shipment for any reason and hereby waives its right to place a lien...
10 Under no circumstances is CARRIER to broker out freight contracted with BOYD TRANSPORTATION GROUP, INC. Should this event occur, BOYD TRANSPORTATION GROUP, INC. has the right to refuse freight payment to CARRIER.

PLEASE LIST BELOW ANY COMPANIES THAT OPERATE UNDER THE AUTHORITY OF THE CONTRACTING CARRIER THAT MIGHT BE USED TO TRANSPORT FREIGHT UNDER THIS AGREEMENT.
